## California Title 24, Cool Roofs and You

If you contract or perform roof construction or maintenance in California, you should be aware of Title 24 regulations – the state's building energy-efficiency standards – that require "cool roofing" for most commercial roof replacement, recoating or recovering applications.

#### What is Title 24?

Title 24 is intended to reduce power consumption, especially during peak daytime hours. One way to do this is by minimizing the effect of urban "heat islands" – areas in cities where temperatures are 3-8 degrees higher than in outlying areas. One cause of urban heat islands is dark roofs that absorb and retain the sun's heat. As rooftop temperatures rise, air conditioners have to work harder to keep buildings cool, so energy use goes up. And as energy demand increases, the cost of energy rises, and power shortages can result.

#### What is a "Cool Roof"?

A cool roof is a roofing material with high solar reflectance and high thermal emittance that reduces heat gain through the roof. To meet California Title 24 requirements, a cool roof must be certified by the Cool Roof Rating Council (CRRC) and meet these minimum guidelines:

- 70 percent reflectance (amount of sun's energy reflected by the surface)
- 75 percent emittance (amount of solar heat released from the surface)
